3. State's Attorney Kristin Heiser Presentation

5. American Public Power Association (APPA) Mutual Aid Commendation to the Berlin Electric Utility Department.

Mayor Williams explained that the Electric Utility was receiving this Commendation for their work during Hurricane Irma. Utility Director Tim Lawrence, Chief Linesman Alan Parkinson and Lineman Claude Littleton had traveled to Orlando, FL in the aftermath of the storm to help restore power. Also present at this meeting, and recognized by Mayor Williams, were Superintendent Augie Wienhold, Chief Lineman Jim Higgason and Meter Technician Barry Daniels, who oversaw the electric department during the aforementioned employees' absence.

6. Departmental Reports:

a. Finance Director - Natalie Saleh

Ms. Saleh indicated that utility meters were being read and the Finance Department was preparing for the upcoming audit.

b. Administrative Services Director - Mary Bohlen

Ms. Bohlen indicated that, to the best of her knowledge, the tennis courts were still on track for completion by August 31st.

c. Electric Utility Director - Tim Lawrence

Mr. Lawrence noted that the replacement lighting project at the Savage Substation and Power Plant was nearing completion. This project was funded by a Maryland Smart Energy Community grant. The Electric Department was also working on the installation of LED lighting at Schooner and Intrepid and completing work at the new development at Purnell crossing. Town electric Utility customers were also advised that the Town expected to "Tweak Our Peak" throughout the week and asked to conserve usage between 2 and 6 PM daily.

d. Police Chief - Arnold Downing

Chief Downing noted that the Police Department had accompanied 40 children with the Worcester Youth and Family Counseling Berlin Youth Program to the trampoline Park in Delmar, DE and thanked Delmar Pizza for their donation of pizza for the group. He indicated that the

Police Department was working with a number of groups gearing up for back to school and indicated that the Department was looking forward to working with States Attorney Heiser.

e. Planning and Zoning Director - David Engelhart

Mr. Engelhart had nothing to report.

f. Managing Director - Jeffrey Fleetwood

Mr. Fleetwood announced that there was a routine workers compensation audit coming up on August 30, 2018 and that the Lower Shore Safety Council would be holding their meeting in Berlin on September 12, 2018.
